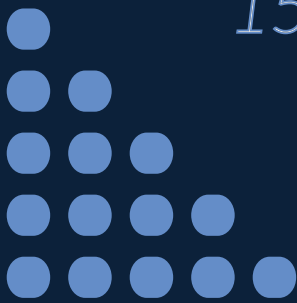

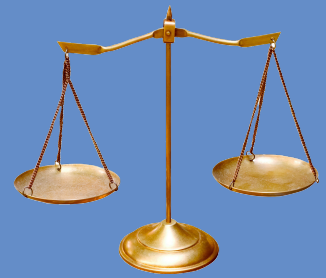

Practical Search and Seizure



Class Description:

This Colorado POST-approved (course ID number LW0027) 8-hour class provides an overview of the Fourth Amendment and pertinent case law that impacts how officers perform their duties. This class provides officers with a clear understanding of what they can and cannot do based on up-to-date legal precedent. The goals of this class are to educate officers and improve their understanding and application of case law.

Class Outcomes:

Upon completion of this course, you will have a better understanding of the following:

- The Fourth Amendment
- How case law applies to U.S. Federal Circuits and States
- Probable Cause and Reasonable Suspicion
- Recent Court decisions concerning consensual contacts, gaining consent to search, reasonable suspicion contacts, developing probable cause, pedestrian contacts, search incident to arrest, curtilage, cellular telephone searches, residential searches, vehicle stops, vehicle searches, vehicle inventory searches, and questioning of witnesses and suspects (Miranda issues).

Eric Stewart is a retired law enforcement officer with 38 years of experience, including approximately 9 years with the Los Angeles County Sheriff's Department (LASD), 23.5 years with the Aurora Police Department (where he retired as a Commander), and 5.5 years with the Loveland Police Department (where he held the ranks of Deputy Chief and Interim Police Chief).
